Council Proceedings January 9, 2023

A regular meeting of the Mayor and Council of the City of Atkinson, Nebraska, was held in the Council Chambers of the Municipal Building at 104 S. Main Street, Atkinson, Nebraska on the 9th of January, 2023 at 7:30 o'clock p.m. The meeting was called to order by Mayor Erickson. On roll call the following were present: Chuck Asher, Ron Krysl, Helen Olson, Riley Olson, Jerry Osborne, Scott Shane, City Clerk Nancy Kopejtka, Deputy City Clerk Shelly Wieneke, and City Attorney Michael Sholes.

Notice of the meeting was given in advance by publication in the Atkinson Graphic, Atkinson, Nebraska, as shown by the affidavit of publication. Notice of the meeting was simultaneously given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mayor Erickson publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated that the poster was on display on the east wall.

City Attorney, Michael Sholes, gave the Oath of Office to Helen Olson as Councilmember.

Moved by Shane, seconded by R. Olson to approve the minutes of the December 5th meeting. RCV: Ayes: Krysl, H. Olson, R. Olson, Osborne, Shane, Asher. Nay: None. Motion Carried.

Treasurer's Report for December was discussed and placed on file.

The council acknowledged receipt of the December minutes of the Library, HCED, Elkhorn Meadows, Chamber of Commerce meetings and the Union Street Duplex Financial Report.

Mayor Erickson opened the public hearing on the Repurposed Public Works Project at 7:35 p.m. Judy Peterson with CNEDD gave a brief overview of the recent downtown sidewalk project to all in attendance. The City of Atkinson at one time had a housing refurbishment assistance program but the number of people applying for this had gone down considerably. The city was able to repurpose the funds into replacing the sidewalks on Main Street in the downtown area instead of turning the funds back to the state of Nebraska. Judy did inform the group that there will be funds available for projects in 2023. After the public was allowed to comment on the project the mayor closed the public hearing at 7:41 p.m.

Moved by Asher, seconded by Osborne to approve the Mayor's appointments. RCV: Ayes: H. Olson, R. Olson, Osborne, Shane, Asher, Krysl, Nay: None. Motion Carried

Asher introduced Ordinance 1181 and moved its adoption: AN ORDINANCE OF THE CITY OF ATKINSON, NEBRASKA, TO REPEAL THE ORIGINAL § 2-507 OF THE MUNICIPAL CODE OF THE CITY OF ATKINSON, NEBRASKA, TO PROVIDE FOR AN EFFECTIVE DATE, AND ORDERING THE PULBICATION OF THE ORDINANCE IN PAMPHLET FORM and moved that the statutory rule requiring reading on three different days be suspended. Osborne seconded the motion. RCV: Ayes: R. Olson, Osborne, Shane, Asher, Krysl, H. Olson. Nay: None Motion carried.

Said ordinance was then read by title and number and thereafter Asher moved for final passage of the ordinance, which motion was seconded by Osborne. The Mayor then stated the question "Shall Ordinance No. 1181 be passed and adopted?" RCV: Ayes: Osborne, Shane, Asher, Krysl, H. Olson, R. Olson. Nay: None. Motion Carried.

Moved by Osborne, seconded by H. Olson to give 30-day notification to Andrea Connot to cancel the contract for cleaning at the Community Center and city office. Andrea Connot has had the contract for this service, but it was decided at this meeting to have an employee of the city clean the Community Center and city office. RCV: Ayes: Shane, Asher, Krysl, H. Olson, R. Olson, Osborne. Nay: None. Motion Carried.

Deputy Clerk Shelly Wieneke disclosed to the council that Mayor Joshua Erickson has filed with the City a Contractual Interest Statement, Nebraska Accountability and Disclosure Commission Form C-3 stating this is a non-exclusive open contract between the City of Atkinson and Joshua Erickson dba Erickson Repair. Erickson Repair will make needed repairs with his welding equipment at the direction of the Utilities Superintendent or the City Council. Claims will be paid 30 days after submission. This contract will have a duration for the term of office elected, which is through 2026. Moved by Osborne, seconded by Asher to approve the Contractual Interest Statement, Nebraska Accountability and Disclosure Commission Form C-3 signed by Joshua Ericson with the added measure that bids must be obtained for any work to exceed \$5000.00. Moved by H. Olson, seconded by R. Olson to approve the bill submitted at this meeting by Joshua Erickson in the amount of \$390.00. RCV: Ayes: Krysl, H. Olson, R. Olson, Osborne, Shane, Asher. Nay: None. Motion Carried.

Update was given to council on getting financial statement from Boyd-Holt E911.

Nobody from their organization has spoke with members of council regarding providing a financial statement to Atkinson. City Attorney Michael Sholes stated that he thinks there was a miscommunication between the City of Atkinson and E911. Boyd-Holt E911 thought that the

City of Atkinson was not going to pay their bill for dispatch services for 2022/2023 and that never stated in any of the council meetings. Ron stated that he had talked to a County Supervisor Monday and he thought that the council would see some financial information from Boyd-Holt E911 soon.

Moved by Asher, seconded by Osborne to approve LB840-122, a business loan to Jesse Slaymaker/ITD (Industrial Technology Distribution) in the amount of \$50,000. Loan was approved on the condition that the outstanding loan on this property is paid in full by Brent Ogden before any funds are disbursed to Jesse. RCV: Ayes: H. Olson, R. Moved by Osborne, seconded by Shane to approve an equipment loan to Atkinson Family Dental in the amount of \$32,231.07. RCV: Ayes: Osborne, Shane, Asher, Krysl, H. Olson, R. Olson.

Moved by Asher, seconded by H. Olson to approve the recommendation by City

Attorney Michael Sholes regarding the confidentiality of LB840 applicants. Attorney Sholes feels that it is best practice going forward to identify an LB840 applicant by name instead of by number in the agenda and minutes. The LB840 program is funded by the taxpayers of the community and they are able to ask who is receiving the funds from this program. A citizen can attend a council meeting and ask who the file number represents and the council owes them that information. However, the Loan board or the City Council cannot and should not disclose any personal financial information about an applicant. That is the information the LB840 guidelines protect. Paul Corkle was present at the meeting and stated that there was 2 city employees scooping driveway and pulling vehicle out at the Dennis and Sherrian Ruppert residence. Charlie Griess, city maintenance employee, stated that he had received a call from the city office regarding a call from Mrs. Ruppert that she had gotten stuck at the end of her driveway in a snow windrow and was unable to exit her vehicle due to the height of the snow. Charlie stated that he went to the address and called another city maintenance employee to bring the backhoe. Charlie stated that the two city maintenance employees were able to push the vehicle out and stated they cleaned the area where the vehicle was stuck in the street. Mr. Corkle advised that he had contacted the State of Nebraska regarding this and that doing this was a misappropriation of taxpayer funds.
